GIFTED ADVISORY COMMITTEE REPORT AND

## GIFTED EDUCATION ANNUAL PLAN

Connie Foreman and Jamie-Ellen Spessard presented the Gifted Advisory Committee Report and Gifted Education Annual Plan. They indicated that enrollment at the Maggie Walker Governor's School and the Blue Ridge Virtual Governor's School had increased. They also indicated that the enrollment in the Elementary Gifted Program at the Specialty Education Center is projected to increase in 2007-08. The Advisory Committee is also working on obtaining funding to support the Lego and Robotics teams

during the coming school year. Additional information regarding the Gifted Program will be presented at the next Board Workshop on June 26.

Mr. Cisne made a motion, which was seconded by Mr. Meng, to approve the Gifted Advisory Committee Report and Gifted Education Annual Plan as presented. The motion was approved unanimously.

### **EMPLOYEE HEALTH INSURANCE**

Sam Rosenthal of Rosenthal Insurance Consulting presented an overview of a proposal for employee health insurance from United Healthcare. United Healthcare's proposal will result in an estimated savings of \$339,000, as compared to the plan offered by the Local Choice. Dr. Morgan recommended that the Board accept the proposal by United Healthcare.

Mr. Mattox made a motion, which was seconded by Mr. Meng, to approve employee health insurance through United Healthcare as presented. The motion was approved unanimously.

## PROPOSED FEES FOR 2007-08

Dr. Morgan presented proposed fees for the 2007-08 school year. He also provided the Board with a list of fees from a neighboring school system as a point of comparison. The three proposed fee increases include Tender Tots (from \$100 to \$125 per week), Behind-the-Wheel Driver Education (from \$225 to \$250), and Parking Pass Fee (from \$25 to \$75). A new fee for Marching Band (\$55) was also proposed.

Mr. Cisne made a motion, which was seconded by Mr. Miller, to approve the proposed fees for 2007-08 as presented. The motion was approved unanimously.

### REQUEST FOR SUPPLEMENTAL APPROPRIATION

Dr. Morgan presented a request from Thomas DeWeerd, Director of Secondary Education, for supplemental appropriation of \$33,018.60 in federal Perkins (Career and Technical) funds.

Mr. Mattox made a motion, which was seconded by Mr. Meng, to approve the proposed fees for 2007-08 as presented. The motion was approved unanimously.

### INFORMATION ITEMS:

### SCHOOL HEALTH ADVISORY BOARD REPORT

Marti Van Epps, R.N., presented the School Health Advisory Board (SHAB) report. Three focus areas were addressed by the group this year, including acquisition of AED devices for all school buildings, increasing alcohol awareness education programs for parents and students, and studying a proposed medical director position and procedures for emergency EpiPen emergency use.

#### VISION, MISSION, GOALS AND PRIORITIES

Dr. Morgan presented a copy of the 2006-08 Vision, Mission, Goals and Priorities for the Board's review, and suggested the Board begin discussion at the June 26 Workshop on possible updates and changes.

#### OLD BUSINESS

- The Middle School Addition construction is still on time. Floor finishing will begin shortly and the movement of furniture to the new facility will begin during the first week of July.
- Graduation took place on June 1 at the Arthur Ashe Center. There were approximately 4,000 people in attendance to see the 175 graduates receive their diplomas.
- Preliminary SOL results look strong. Testing was done on-line, which went very well.

#### CLOSED MEETING

Mr. Meng made a motion, which was seconded by Mr. Cisne, to go into closed meeting pursuant to Virginia Code §2.2-3711(A)(2) for the discussion or consideration of the hiring of an Assistant Principal at Goochland High School, the appointment of an Interim Superintendent and the performance of all principals, assistant principals, and other administrative personnel. The motion was approved unanimously.

Mr. Mattox made a motion, which was seconded by Mr. Miller for the Board to come out of Closed Meeting. The motion was approved unanimously.

### CERTIFICATION OF CLOSED MEETING

Mr. Miller made a motion, which was seconded by Mr. Meng for approval of the Certification of Closed Meeting. The motion was approved unanimously.

#### **ACTION ITEM**

Mr. Miller made a motion, which was seconded by Mr. Meng, to appoint Karen S. Kelley as Assistant Principal at Goochland High School effective July 1, 2007.

Mr. Cisne made a motion, which was seconded by Mr. Mattox, to appoint Dr. Linda Underwood as Interim Superintendent effective July 1, 2007 until such time as a Superintendent is hired, and that she be compensated an additional \$35 per day for every day that she serves as Interim Superintendent.
