ADDITIONS/DELETIONS/CHANGES TO AGENDA

Dr. Underwood presented additions and changes to the agenda.

RECOGNITION

Bryan Smith, John Julock, Scott Spivey, and Dave Smith, all from LuckStone, presented a check in the amount of \$5,000 to the Robotics Team.

STATEMENT

At this time Mr. Miller read the following statement for the record:

"I'd like to take this opportunity to thank those who have engaged the board during the beginning phase of our budget preparation. You have done a great job of communicating your priorities and we are fortunate to have heard from all of you.

The annual school budget process takes its next step after tonight. The School Board now has the responsibility of constructing a budget that is responsive to student needs and community expectations. We will continue to work until the school budget is forwarded on January 22 to the Board of Supervisors for its approval.

The 2010-2011 school year will be especially challenging for Goochland as with school systems across the nation. Universally, school systems are experiencing decreasing revenues and increasing costs. These two factors have led to the inevitable conclusion that painful cuts in school programs will have to be made.

During the past month, we have solicited input from the public. You have responded and two themes came through loud and clear:

Goochlanders do not expect their school system to be "average" or to just meet "state standards."

You are, and will be, supportive of the school system in a very passionate way.

As chairman and a member of a five-person board, I can say without reservation I too support these two positions. Further, I will do all I can to see that we send to the Board of Supervisors a responsible budget that will continue to move Goochland forward."

PUBLIC HEARING ON BUDGET

Dr. Underwood presented an overview of the budget process prior to the public hearing.

- Jane Christie spoke asking for confirmation of the current annual cost of health insurance, and the total annual cost per student for students attending Maggie L. Walker Governor's School. She also asked the School Board to consider giving the gifted center back to the gifted program rather than it being the 3rd grade wing of Goochland Elementary School. She asked that the School Board consider making only one bus stop at the gifted center. Ms. Christie asked for an explanation of the increase in the coaching budget as well as an accounting of all administrative staff positions, both full-time and part-time.
- Monica Smith spoke regarding the TOP program and asked for information regarding what will happen to the program with the budget. She feels that with the increase in classroom size, there is the tendency for an increase in behavior issues and feels the TOP program is vital to the school system.
- Jo D. Hosken thanked the School Board for listening to the gifted parents. She also asked that the Board and Superintendent open the lines of communication with parents.

Mr. Miller stated public hearing will be continued to January 12, 2010 at Goochland High School.
